#### NYSAEMC/CAC Forum :

- Municipalities are asked to consider adopting (by resolution) the new
   DEC Climate Smart Communities Pledge. Contact Allison for more info.
- The EMC may want to consider sponsoring a pharmaceutical take back day to help protect water resources. There may be grant opportunities for small community grants.
- EMC Enabling Legislation update Rachel will prepare and send her notes on the enabling legislation to Allison and Lalita. Allison will follow-up with a meeting with the Legislature's attorney.
- Website Coordination Judith and John provided a summary of the work to update the website. Judith will contact Suzan Myrtle (volunteer web designer). Allison will follow up on CCEDC's decision on the web format.
- NRI update Allison provided an update on NRI activity. The climate chapter will be online soon. Allison and Neil are working on the Introduction. Other authors are working on the Geology/Topography, Soils, Hydrology and Biological chapters. John is working on the glossary for the NRI. There will be a meeting soon with the entire NRI committee.
