Special Presentation by CCEDC's Jeff Luoma on Organics Recycling Project:

Jeff Luoma reported on a project CCEDC is conducting on organics recycling in Dutchess County. The project is funded by NYSERDA and will provide the County with recommendations for improving its recycling rate through improved organics recycling. Parenthetically, Jeff reported that the County could use EMC help in promoting and providing information to the public on single stream recycling, especially contamination by plastic bags. Peter Berasi reported that, from a EPA webinar he attended, he learned that the two most important factors determining the health of a recycling program are economics of the recycled material and contamination.
