Reports:

Natural Resource Inventory for Dutchess County: The kickoff meeting of the steering committee was postponed until June 6. Sean Carroll sent a survey to CAC's. The EMC members should all complete the survey.

Road Salt Brine Cost Benefit Analysis (Vicky, Candis, Jim, John): Vicky reported that, a cost benefit analysis was circulated to the committee. The data used for the analysis came from phone calls, email correspondence and a literature search. The town of Rhinebeck is the only municipality in Dutchess County that responded that they use brine. The highway superintendent was very open with information. The Town of Hague near Lake George uses brine as well as other methods to reduce salt. They have been very successful and are very willing to share information. Reports indicate that using brine to pretreat roads before a storm significantly reduces overall salt use such that the cost of new equipment would be recovered in less than one year from salt savings. Vicky will draft a cover letter and make a recommendation for distribution of the report.

Environmental Advocacy Group Monitoring Updates (Nancy, Candis):

Nancy Severns reported:

- Sierra club Mid Hudson group- No formal response yet on A8431 (all electric buildings) and A9329 (gas transition and affordable energy act) from Jonathan Jacobson. He is cosponsoring other legislation.
- Poughkeepsie's Wheaton Park was sold to developers on a contract loophole. As a result, city council has hired its own legal representation.
- Catskill Mountainkeeper no news with respect to Dutchess County. No legal decision on Bluestone Wild Forest.
- Sloop Clearwater is not holding Clearwater Festival in 2022. Determined a new strategic plan.

Candis Sunderland reported:

- The DEC has scheduled an overview of model battery storage system law that is geared toward town boards.
- The Dutchess Co. Industrial Development Agency is moving forward on the Dutton site on the Hudson River, which will be developed.

Other Business:

A motion to adjourn was made by Candis Sunderland. The next regularly scheduled meeting of the EMC is June 22, 2022 at 7:00 p.m.
