Natural Resource Inventory for Dutchess County (all): Sean reported that Kelsey, Vicky & he met to discuss the climate chapter. The next meeting of the steering committee will likely be mid-late January when there should be some content to review.

Road Salt (Vicky, Candis, Jim, John): Jim discussed a forum and a meeting with legislators and Bob Wyant. Candis discussed a meeting at the Putnam County facility about brine use. Tom Knapp of East Fishkill was at the meeting and expressed interest in using brine but it isn't clear if he has. The group discussed how to get more towns interested in pursuing brine use. Vicky will send an email to the CAC/EMC listserve suggesting that they pursue the issue with their town highway personnel with a potential field trip to the Rhinebeck facility.

Environmental Advocacy Group Monitoring Updates (Nancy, Candis):

Nancy reported the following:

Sierra Club, no organizational news. Conservation Committee was aware of SaveLaGrange.org, a community led organization trying to stop a hot mix asphalt plant on Commerce Street from being approved by Town Board. Zoning Board of Appeals meeting was held 5 December but minutes were not yet posted. The applicant postponed the appeal until January 9, 2023.
